KTOP-FM's "ZBB LIVE STREAM" CONTEST

OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station KTOP-FM ("Station"), owned and operated by Cumulus Broadcasting LLC or one of its affiliates, located at 825 S Kansas Ave Suite 100 Topeka, KS 66612, during available business hours Monday through Friday, Station's website at eagle993.com or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **KTOP-FM's "ZBB Live Stream"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. No purchase is necessary to enter or win. A purchase will not increase your chance of winning. Void where prohibited. All federal, state, and local regulations apply.
 - **Eligibility.** This Contest is open only to legal U.S. residents, or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last 30 Days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 30 Days or a prize valued at \$500 or more in the last 180 days. Void where prohibited by law. Employees of Cumulus Broadcasting LLC, Station, each of its parent company, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein. This Contest is in no way sponsored, endorsed, administered by or associated with Facebook.
- 2. Contest Period. The Contest will begin at 7:15am CT on April 26, 2021 and will run through 8:59am CT on April 30, 2021 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. How to Enter. Visit the Station's Facebook Page located at facebook.com/1029nashicon during the Contest Period and comment on the designated contest post to enter. All entries must be received by 8:59am CT on Friday, April 30, 2021 to be eligible to win a prize. Limit one (1) entry per person per day, regardless of how many emails/Facebook accounts a person may possess and use. Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry by using multiple/different email addresses/Facebook accounts, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the participant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the right to

contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries will be accepted.

4. Winner Selection.

On or around 8:59am CT on Friday, April 30, 2021, the Station will select five (5) entries in a random drawing from among all valid entries received by Station during the Contest Period.

The winning entrants will be contacted using the Facebook account, email address and/or telephone number provided with the entry and may be awarded the prize and qualify for the Grand Prize drawing (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.

Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 5. IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. Winner is responsible for all taxes associated with prize receipt and/or use. Odds of winning the prize depend on a number of factors including the number of eligible entries received during the Contest Period and listeners participating at any given time.

There is no substitution, transfer, or cash equivalent for prizes, except that the Station may, at its sole discretion and to the extent permitted by law, substitute prizes of comparable value or cash.
